- 3. Two Passport Photos:** NOT A COPY OF YOUR PASSPORT– Two passport photos with a white background, nothing else will be accepted, no ID card will be issued unless this requirement is meet.
- 4. Letters of Reference:** Two letters of reference from someone that knows you and your efforts to help the suffering & needy.
- 5. Photocopy of Current driver's license or State ID card:** Identification must be verified, forward with your application a photocopy of your Current driver's license. Applicants must have a US Driver's License or State ID card.

ID cards are produced with commercial ID equipment owned by CFMI which protects your personal information from identity theft. Your personal information is kept in locked file cabinets at all times. It never leaves our office for any reason. We do not trade, share, lease or sell our member's personal information to anyone for any reason.
